Thank you for your interest in the Corporate Golf Package at St. Boniface Golf Club. We are located less than 4 kilometers from Portage and Main and offer an excellent value, as well as a challenging, well-maintained golf course. We look forward to welcoming you to the Club.

Corporate Vouchers

The Corporate Golf Package consists of 100 golf vouchers that can be used by an individual, passed on to clients and customers, or used as staff incentives and rewards. One voucher is equivalent to one round of golf when redeemed at the Pro Shop prior to play.

Vouchers will be ready for pick up at the administration office after April 1st. Any un-used vouchers will be re-issued ONLY if the Corporation re-purchases vouchers in the following year. Expired vouchers must be handed into the administration to be re-dated for the next year.

With the purchase of corporate vouchers a Corporation may purchase up to 2 Non-Restricted Memberships for \$1550.00 (plus GST) per membership and each pay a \$375.00 food & beverage assessment (valid from April 1st to October 31st of the season).

Tee Time Booking (12 day advance booking)

Tee Times for Corporate members are:

Mon-Thurs - no restrictions

Fridays – must tee off before 2:00pm

Sat, Sun & Holidays – tee off after 11:00am

Each Corporation is limited to two tee times per day. When booking a tee time it must be booked under the Corporate Name.

How it works:

- Enter tee times 12 days in advance at www.drivetheball.com
- You will require a 5-digit id number and password. Contact the Proshop to be set up @ 233-4276.
- Phone in tee times will still be also be accepted.
- If you have any questions regarding tee time bookings please ask the Pro Shop staff for assistance.

Charging Privileges

Charging privileges can be set up for Corporate Members by filling out and signing the last page of this package and returning it to the Administrative office.

Corporate

- Tee times booked the same day as play are subject to availability without restriction.
- Groups of five are not permitted for those utilizing corporate privileges.
- Club storage is available at a cost of \$100.00 plus GST.
- Only one locker is available per corporate member; additional lockers are available @ a charge of \$35.00 plus GST.
