# Tournament Terms & Conditions

## INITIAL PAYMENT:

Tournaments with under 100 players are required to pay a **\$500.00** initial payment.

Tournaments over 100 players require a **\$1000.00** initial payment.

Initial payments are non-refundable and non-transferable. This payment will be applied to your final invoice, barring any damage to the course and equipment. *In.*\_\_\_\_\_

## FINAL PAYMENT:

The Balance of the total costs accrued is due within **7 days** upon completion of your event. The 10% booking incentive for over 100 players will be applied at this time. You will be invoiced via e-mail within 3 business days of your event. If payment is not received within the above guidelines, the credit card listed on the contract will be charged for the full amount owing. A charge of 2% per month will be applied on all overdue accounts. *In.*\_\_\_\_\_

## GUARANTEED NUMBERS:

Guaranteed numbers for golf and a list of all golfers is required no later than **3 days** prior to the tournament. Guaranteed numbers for all meal service is required **5 business days** before the event. If guaranteed numbers are not received within the above guidelines; St Boniface Golf Club will prepare for the estimated number of guests indicated on the contract and reserves the right to invoice for the total estimated number of guests or the total actual number of guests; whichever is greater, for both golf and meal service. *In.*\_\_\_\_\_

## DAMAGES:

Any damages to the facility, golf course, rental equipment such as power carts, clubs, etc are the responsibility of the tournament organization. Any cost occurred with these damages will be charged on your final invoice. *In.*\_\_\_\_\_

## CONSUMPTION OF ALCOHOL:

Due to LGA regulations, the St. Boniface Golf Club must supply all alcoholic beverages consumed on the golf course. **Private Coolers are NOT Permitted!** Please ensure the golfers in your group are aware of our Tournament Rules & Regulations to prevent any problems or embarrassment. *In.*\_\_\_\_\_

## TEE TIME TOURNAMENTS:

All golf events under 100 players are subject to tee times beginning at **11am** or a modified shot gun start at the discretion of St. Boniface Golf Club. *In.*\_\_\_\_\_

## SHOT GUN TOURNAMENTS:

All shot gun events must have a minimum of 100 players or pay the equivalent course rental. Full field events are to be held Tuesday-Thursday with a 12:00pm start time, unless otherwise approved by St. Boniface Golf Club. *In.*\_\_\_\_\_

## FOOD & BEVERAGE:

All organized golf events with over 20 participants are required to arrange for a minimum of one, pre-ordered meal. All food and beverage service must be provided by the golf club unless otherwise approved by the Director of Food & Beverage. Guaranteed numbers and special meal arrangements must be **confirmed 5 business days prior to your event**. If confirmation is not received you will be billed for your estimated number of attendees or amount in attendance whichever is greater. *In.*\_\_\_\_\_
